GENERAL DATA PROTECTION REGULATION (GDPR)

WHAT IS GDPR?

EU Regulation (EU) 2016/679 of the European Parliament and of the Council on the Protection of Personal Data, known as the General Data Protection Regulation GDPR.

EXPLANATORY STATEMENT

Since the regen.hu wesite is not required to issue an invoice, which would include (mandatory) client data, and does not collect any other personal data, the so-called GDPR (General Data Protection Regulation) that came into force on the date on 25 May 2018, this EU directive, European Union and Council regulations is not mandatory on the site, however, the old rules have been updated.

IN EUROPEAN UNION

REGULATION NO. 679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data is a fundamental right. Article 8 (1) of the Charter of Fundamental Rights of the European Union (the Charter) and Article 16 (1) of the Treaty on the Functioning of the European Union (TFEU) provide for the right of any person to the protection of personal data concerning him

IN EVERY COUNTRY

Each person concerned shall have the right to lodge a complaint with a supervisory authority, in particular in the Member State in which he has his or her habitual residence, place of work or place of infringement of the rights of the data subject if it considers that the processing of personal data concerning it is in breach of this Regulation.

WHO IS OBLIGATORY

For anyone who manages personal data by: billing, recording, collecting, storing, using, modifying, transferring, redirecting. He is the Data Manager. To whom the data will be transmitted, is the Data Processor.

GOOGLE

This site is collecting outside data: Google Analytics, Google ads, therefore, personal data protection is owned by Google and is subject to Google's GDPR Rules. Since the first day of the web site regen.hu has been added rules, but these rules were updated on May 25, 2018.

On website regen.hu runs ONLY Google Analytics, Google Ads (Ads) and Cookie Visitor Reviews, and no personal information is collected in other ways (bulletin, blog, bulletin, remarketing, etc.), so no change is required on the site because the data is taken over by Google. Google rules...

RIGHT OF ACCESS BY THE DATA SUBJECT (GDPR)

RIGHT TO BE INFORMED:

The controller shall take appropriate measures to provide any information, and any communication concerning the processing to the data subject in a concise, transparent, intelligible and easily accessible form using clear and simple language, in particular for any information specifically addressed to a child. Note: No personal data is collected on this site. These current rules contain information. **Note**: No personal data is collected on this site. These current rules contain information.

RIGHT OF ACCESS:

The data subject shall have the right to obtain from the controller confirmation as to whether or not personal data concerning him or her are being processed, and, where that is the case, access to the personal data and the following information: the purposes of the processing; the categories of personal data concerned.

Note: We do not collect personal, confidential and sensitive data.

THE RIGHT OF CORRECTION:

The data subject shall have the right to obtain from the controller without undue delay the rectification of inaccurate personal data concerning him or her. Taking into account the purposes of the processing, the data subject shall have the right to have incomplete personal data completed, including by means of providing a supplementary statement.

Note: Applies only to personal data. We do not collect personal, confidential and sensitive data.

RIGHT TO ERASURE:

('right to be forgotten') The data subject shall have the right to obtain from the controller the erasure of personal data concerning him or her without undue delay and the controller shall have the obligation to erase personal data where one of the following grounds applies: the personal data are no longer necessary; the data subject withdraws consent on which the processing; there are no overriding legitimate grounds for the processing; the data subject objects to the processing.

Note: Applies only to personal data. We do not collect personal, confidential and sensitive data.

RIGHT TO RESTRICTION OF PROCESSING:

The data subject shall have the right to obtain the restriction of processing where one of the following applies: the accuracy of the personal data is contested by the data subject; the processing is unlawful and the data subject opposes the deletion of the personal data; the controller no longer needs the personal data for the purposes of processing; the data subject has objected the processing data.

Note: Applies only to personal data. We do not collect personal, confidential and sensitive data.

RIGHT TO DATA PORTABILITY:

The data subject shall have the right to receive the personal data concerning him or her, which he or she has provided to a controller, in a structured (for example, .doc, .pdf, etc.), commonly used and machine-readable format and have the right to transmit those data to another controller without hindrance from the controller to which the personal data have been provided, where: the processing is based on consent, or on a contract; the processing is carried out by automated means. In exercising his or her right to data portability, the data subject shall have the right to have the personal data transmitted directly from one controller to another, where technically feasible.

Note: Applies only to personal data. We do not collect personal, confidential and sensitive data.

RIGHT TO PROTEST:

The data subject shall have the right to object, on grounds relating to his or her particular situation, at any time to processing of personal data concerning him or her, including profiling based on those provisions. The controller shall no longer process the personal data unless the controller demonstrates compelling legitimate grounds for the processing which override the interests, rights and freedoms of the data subject or for the establishment, exercise or defence of legal claims. Where personal data are processed for direct marketing purposes, the data subject shall have the right to object at any time to processing of personal data concerning him or her for such marketing, which includes profiling to the extent that it is related to such direct marketing.

Note: Applies only to personal data. We do not collect personal, confidential and sensitive data.

RIGHT TO RECLAMATION:

Without prejudice to any other administrative or judicial remedy, each person concerned shall have the right to lodge a complaint with a supervisory authority, in particular in the Member State in which he has his or her habitual residence, place of work or place of infringement of the rights of the data subject if it considers that the processing of personal data concerning it is in breach of this Regulation. The supervisory authority where the complaint was filed shall inform the complainant of the progress and outcome of the complaint, including the possibility of resolving the complaint
